Terms and Conditions of Recognition

1. **Duration:** The recognition period will not be extended, and there is no obligation to grant recognition or affiliation beyond grade 8th under any circumstances.
2. **Compliance:** The school shall follow the provisions of the RTE Act, 2009 (Annexure 1) and Maharashtra RTE Rules, 2011 (Annexure 2).
3. **RTE Admissions:** The school shall admit children from weaker sections and disadvantaged groups in the first grade to the extent of at least 25% of the class strength and provide free and compulsory education until the completion of primary education. This also applies to pre-primary classes.
4. **Reimbursement:** The school will receive reimbursement for children specified in paragraph 3 as per Section 12(2) of the Act via a separate bank account.
5. **No Fees/Screening:** The institution/school shall not collect any capitation fee or subject any child or their parents to any screening procedure.
6. **Non-Discrimination:** No child shall be denied admission due to lack of proof of age, or based on religion, caste, race, place of birth, or any such reasons.

7. **Student Welfare:** * No child shall be held back in any class or expelled until the completion of primary education.
 - No child shall be subjected to physical punishment or mental harassment.
 - No child is required to pass any board examination until primary education is completed.
 - Every child completing primary education shall be issued a certificate as per Rule 23.
8. **Staffing:** Teachers with minimum qualifications as per Section 23(1) of the Act shall be appointed. Teachers without such qualifications at the start of the Act must acquire them within 5 years.
9. **No Private Tuitions:** The school shall ensure that teachers do not engage in private tuition work.
